# Instructions

The Nominating Committee of the Churchwide Assembly is responsible for nominating people for each position for which an election will be held. In advance of the assembly, the Nominating Committee seeks names for consideration. Nominations in specific categories also can be made by voting members on the floor of the assembly.

This booklet is designed to aid you in recommending names to the Nominating Committee. For each committee or board for which there will be an election, you will find the following information:

- a list of continuing members of the council, board or committee,
- a list of departing members, who are ineligible for re-election,
- a list of any restrictions placed on a given nomination, along with needs and preferences,
- a summary of the election process with pertinent constitutional excerpts, and
- the positions for which nominations are sought.

The Nominating Committee welcomes the names of people who would be appropriate for positions on the Church Council, the boards of separately incorporated ministries and churchwide committees. Please provide the Nominating Committee with the names and contact information of people you deem qualified for the various positions indicated, and please encourage others to submit nominations as well.

The nominations process is governed by principles detailed in the *Constitution, Bylaws,*

*and Continuing Resolutions of the Evangelical Lutheran Church in America.* Please nominate only people who match the requirements of a given category. For information on restrictions and representational principles, please see the next page of this booklet.

Each person is required by the ELCA constitution to provide an information form to the Nominating Committee. The form is online at <http://webapps.elca.org/secretary/nominations/>. A sample of the form is printed at the back of this booklet. The constitution requires that all information on the form be completed and verified. If you provide the individual's name and contact information, **by April 1, 2019**, the Office of the Secretary will follow up and obtain the background information.

A rostered minister of this church will be asked to provide her or his leader key when completing the form. Other ELCA members will be asked for the name of the congregation in which she or he holds membership.

Thank you for your prayerful attention to this important part of our work together in this church.

# Notes about Restrictions on Nominations

**Re-election:** Trustees on the boards of separately incorporated ministries may serve up to three consecutive three-year terms. Incumbents identified by an asterisk (\*) were elected by the Church Council to complete less than half of an unexpired term and are eligible for re-election. The Nominating Committee may or may not choose to nominate such incumbents as it deems appropriate. All individuals listed as “departing members” are *ineligible* for re-election and will not be nominated for that body.

**One nominee:** The Nominating Committee may choose to nominate only one person for possible election to each position on the board of a separately incorporated ministry (ELCA bylaw **19.11.03.**) and in certain other cases of possible re-election (**19.11.02.**).

**Geographic restrictions:** The *Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America* places the following restrictions upon geographic representation:

- (1) **Synod representation:** The Church Council shall endeavor to ensure that every synod has at least one person serving on the Church Council or churchwide boards, committees, task forces, or other groups. Among those persons elected by the assembly, no more than two persons from any one synod shall serve on the Church Council or any one board, committee, task force, or other group (**19.11.05.**).
- (2) **Nominating Committee:** The committee shall consist of at least one member but no more than three members from any region (**19.11.01.**).

As you consider possible nominees, please look carefully at the synod designations for continuing members and related restrictions to be certain that the nominee is eligible according to geographic rules. A list of regions and synods appears below.

**Inclusive representation:** Nominations made by the churchwide Nominating Committee will reflect this church’s commitment to inclusive representation as explained in Chapters 5 and 6 of the ELCA constitution. Positions are identified according to mandatory categories: Minister of Word and Sacrament, Lay Female, Lay Male, PC/L (person of color or whose primary language is other than English) and Y/YA (youth and young adult). Nominees born on or since August 8, 2001, are eligible to be elected as youth, and nominees born on or since August 8, 1989, are eligible to be elected as young adults by the 2019 Churchwide Assembly (**6.02.A09.**).

## Summary

Church Council members are elected to a six-year term, except for two youth members who are elected to a three-year term.

The 2011 Churchwide Assembly adopted a new structure for the Church Council that included a range of 33 to 45 members in addition to the four officers and the chair of the Conference of Bishops.

The 2016 Churchwide Assembly elected 11 Church Council members from synod nominees. To facilitate a nomination process every three years involving 16 or approximately a quarter of the 65 synods, the assembly adjusted the council's size from 32 to 45 members in addition to the four officers and the chair of the Conference of Bishops.

**Restrictions:** Departing members are not eligible for nomination. It is not possible to nominate more than one individual from the same synod of a continuing member of the Church Council, unless on the same ticket.

**Needs:** At least five additional lay members and two youth, a person of color or whose primary language is other than English who has financial expertise and an attorney.

## Church Council *(continued)*

The 2019 Churchwide Assembly will elect Church Council members from the nominees from 16 designated synods. With the 11 members elected in 2016, the assembly must elect an additional five members for the council to have a minimum of 32 members.

The Nominating Committee is responsible for nominating two female youth and two male youth for possible election to a three-year term on the council. Nominees born on or since August 9, 2001, are eligible to be elected as youth by the 2019 Churchwide Assembly.

- 14.31. The voting members of the Church Council shall consist of the four churchwide officers, the chair of the Conference of Bishops, and at least 32 and not more than 45 other persons elected by the Churchwide Assembly.**
- 14.32. With the exception of youth members, Church Council members shall be elected by the Churchwide Assembly to one six-year term and shall not be eligible for consecutive re-election. Youth members of the Church Council shall be elected by the Churchwide Assembly to one three-year term.**
- 19.02. The members of the Church Council, except the chair of the Conference of Bishops and the treasurer of this church, shall be elected by the Churchwide Assembly. In preparation for the Churchwide Assembly, the Church Council shall determine how this church's commitment to inclusive representation will affect the next election to the Church Council. For 32 of the council members, the Nominating Committee shall invite each eligible synod to submit suggested nominees and shall then nominate persons who fulfill the categories assigned by the Church Council. With respect to the other nominees, the Church Council shall review its size and composition and take into consideration the experience and expertise of existing members and synodical nominees as well as the needs of the council in seeking to fulfill its duties and responsibilities. Based upon this analysis, the Church Council shall instruct the Nominating Committee to provide nominations in specific categories for the remaining positions up to 13. Excluding the churchwide officers and the chair of the Conference of Bishops, there shall not be more than two members of the Church Council from a synod. The Church Council shall have at least two members from each region. ...**
- 19.02.A13. *The Nominating Committee shall strive to ensure that at least 10 percent of the voting membership of the Church Council shall be youth or young adults. Youth members shall be younger than 18 at the time of their election, and young adults shall be older than 18 and younger than 30 years of age at the time of their election.***
- 19.04. Unless otherwise specified in the *Constitution, Bylaws, and Continuing Resolutions*, elections shall be for one six-year term, without consecutive re-election, and with approximately one-half of the members of the Church Council and of each board or advisory committee elected each triennium.**

## Summary

Trustees of the Board of Pensions of the ELCA (Portico Benefit Services) are elected to a maximum of three consecutive three-year terms. The board of trustees has a range of 14 to 18 members with expertise in investments, insurance and retirement plans. Only one person need be nominated for each position on the board of a separately incorporated ministry. Up to two trustees from church bodies with which this church is in a relationship of full communion may serve as long as they are not from the same church body.

The 2019 Churchwide Assembly will complete the transition to a triennial election cycle by electing all Portico trustees, with an appropriate mix of new and continuing members elected.

**17.20.03.** The Board of Pensions shall have a board of trustees composed of 14–18 persons elected by the Churchwide Assembly for three-year terms with the possibility of two consecutive re-elections. The terms of members of the board of trustees elected by the Churchwide Assembly shall begin at the commencement of the first board meeting following the assembly.

- a. The composition of the board of trustees shall comply with the representational principles described in constitutional provision 5.01.f. The board of trustees of the Board of Pensions shall include persons with expertise in investments, insurance, and retirement plans, and at least four persons who are members of the plan, at least one of whom shall be a lay plan member or lay recipient of plan benefits and at least one of whom shall be a minister of Word and Sacrament who is a plan member. Up to two trustees may be members of congregations of church bodies with which this church is in a relationship of full communion, provided that both are not from the same church body....

**19.11.03.** The Nominating Committee shall nominate at least one person for the board of trustees of each of the separately incorporated ministries identified in Chapter 17 of this constitution, according to the process described in continuing resolutions, for which an election will be held by the Churchwide Assembly. Nominations from the floor, where permitted in the nomination process, shall be presented as an alternative to a specific category named by the Nominating Committee and shall therefore meet the same criteria as the persons against whom the nominee is nominated. In the materials provided in advance to each member of the assembly, the Nominating Committee shall set forth the criteria applicable to each category that must be met by persons nominated from the floor.

## Summary

Trustees of the Endowment Fund of the ELCA are elected by the Church Council. If the 2019 Churchwide Assembly decides to make the Endowment Fund a separately incorporated ministry of this church which has trustees elected by the Churchwide Assembly, the assembly will consider this slate of nominees for election.

The board of trustees would have a range of nine to 15 members with expertise in business, investments and finance. Only one person need be nominated for each position on the board of a separately incorporated ministry of the ELCA. Trustees are elected to a maximum of three consecutive three-year terms. Up to two trustees from church bodies with which this church is in a relationship of full communion may serve as long as they are not from the same church body.

If the proposed changes to the constitution below are adopted, the 2019 Churchwide Assembly will elect all trustees on the board, with an appropriate mix of new and continuing members. The Church Council will divide the trustees into three classes — one class eligible for three terms, another class eligible for two terms, and yet another class eligible for one term.

*New bylaw and continuing resolution for consideration by the 2019 Churchwide Assembly*

**17.60.01.** The Endowment Fund shall have a board of trustees composed of the presiding bishop of this church and 9–15 persons elected by the Churchwide Assembly for three-year terms with the possibility of two consecutive re-elections. Any vacancies occurring because of the death, resignation, or removal of a member of the board of trustees shall be filled by the Church Council for the unexpired term of such member of the board of trustees. The composition of the board of trustees shall comply with the representational principles described in constitutional provision 5.01.e. Up to two trustees may be members of congregations of church bodies with which this church is in a relationship of full communion, provided that both are not from the same church body.

**17.60.B19** *Initial Election of Board of Trustees of Endowment Fund Under Chapter 17*

*For the first election of members of the board of trustees of the Endowment Fund under this Chapter 17, the Church Council shall divide the currently serving trustees, other than the presiding bishop, into three classes: one class which shall be deemed to have served one full term and be eligible for election to two more terms; one class which shall be deemed to have served two full terms and be eligible for election to one more term; and one class which shall be deemed to have served three full terms and not be eligible for further election.*

Trustees of the Mission Investment Fund of the ELCA are elected to a maximum of three consecutive three-year terms. The board of trustees has a range of nine to 12 members with expertise in lending, investments and finance. Only one person need be nominated for each position on the board of a separately incorporated ministry of the ELCA. Up to two trustees from church bodies with which this church is in a relationship of full communion may serve as long as they are not from the same church body.

At its Spring 2017 meeting, the Church Council elected the Rev. Martín J. Lopez-Vega and Ms. Nicole Hudson to a two-year term expiring in 2019. This was necessitated by the transition from a biennial to a triennial election cycle.

The 2019 Churchwide Assembly will complete the transition to a triennial election cycle by electing all Mission Investment Fund trustees, with an appropriate mix of new and continuing members elected.

**17.30.01.** The Mission Investment Fund of the Evangelical Lutheran Church in America shall have a board of trustees composed of 9–12 persons elected by the Churchwide Assembly for three-year terms with the possibility of two consecutive re-elections. The terms of members of the board of trustees elected by the Churchwide Assembly shall begin at the commencement of the first board meeting following the assembly. The composition of the board of trustees shall comply with the representational principles described in constitutional provision 5.01.f. Up to two trustees may be members of congregations of church bodies with which this church is in a relationship of full communion, provided that both are not from the same church body.

**19.11.03.** The Nominating Committee shall nominate at least one person for the board of trustees of each of the separately incorporated ministries identified in Chapter 17 of this constitution, according to the process described in continuing resolutions, for which an election will be held by the Churchwide Assembly. Nominations from the floor, where permitted in the nomination process, shall be presented as an alternative to a specific category named by the Nominating Committee and shall therefore meet the same criteria as the persons against whom the nominee is nominated. In the materials provided in advance to each member of the assembly, the Nominating Committee shall set forth the criteria applicable to each category that must be met by persons nominated from the floor.

In accordance with continuing resolution **20.64.A16**. (below), at its Spring 2017 meeting, the Church Council elected the Rev. Paul J. Blom, the Rev. Christine A. Timm, Ms. Lesley M. Houston and Mr. George K. Rahdert to serve on the Committee on Appeals until the 2019 Churchwide Assembly. These individuals are eligible for re-election to a full term by the assembly without opposition, having served less than half of a six-year term.

The 2019 Churchwide Assembly will elect eight members of the committee, and the 2023 Churchwide Assembly will elect four members of the committee.

The continuing membership of the committee, after the 2019 Churchwide Assembly, will consist of four ministers of Word and Sacrament, two lay females and two lay males. If the assembly is to complete the transition to a triennial election cycle, electing half of the committee's members, it may elect eight ministers of Word and Sacrament, four lay females and four lay males.

**20.21.08.** A discipline hearing committee shall be convened to conduct a hearing. The voting members of this committee shall be composed of 12 persons of whom six shall be selected by the Synod Council's Executive Committee from the Committee on Discipline of the synod and six shall be selected from the churchwide Committee on Discipline....

**20.21.11.** The Churchwide Committee on Discipline shall consist of 24–36 members, half of whom should be ministers of Word and Sacrament and half of whom should be laypersons, elected by the Churchwide Assembly for a term of six years. Each member will serve until a successor is elected, without consecutive re-election, and will serve as needed on a discipline hearing committee in any of the synods in this church.
